

# Terms and Conditions for the Processing of Personal Data for ETFobchodník Marketing Campaigns

## 1. Introductory provisions

1. This document sets out the terms and conditions for the processing of personal data (hereinafter referred to as the “Terms and Conditions”) by **CAPITAL MARKETS, o.c.p., a.s.**, with its registered office at Slávičie údolie 106, Bratislava – Staré mesto district 811 02, Company ID No.: 36 853 054, registered in the Commercial Register maintained by the Municipal Court Bratislava III, File No. 4295/B, Section Sa., which operates the ETFobchodnik brand ([www.etfobchodnik.com](http://www.etfobchodnik.com)) (hereinafter referred to as the “Operator”) in connection with marketing campaigns carried out via social media (Facebook, Instagram) or the Operator’s website.
2. Personal data is processed in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data (hereinafter referred to as the “GDPR”) and other applicable legal regulations.

## 2. Scope and purpose of personal data processing

1. Personal data obtained via online forms on social media (Facebook, Instagram) or on the Operator’s website is processed for the purpose of:
  - contacting potential clients (data subjects) and providing information about the services offered by the operator;
  - Transferring the data subjects’ personal data to third parties (the operator’s partner companies), which will process the data subject’s personal data solely for the purpose of contacting the client in connection with registration on the operator’s website and the provision of the operator’s other investment-related services.
2. The following categories of personal data are processed:
  - First name and surname
  - Telephone number
  - Email address

## 3. Legal basis for processing

1. The legal basis for the processing of personal data is **the consent of the data subject** within the meaning of Article 6(1)(a) of the GDPR.
2. The data subject gives their explicit consent to the processing of personal data for the purpose of being contacted by the operator or its partners when filling in a form on social media or the operator’s website.
3. **Where personal data is processed for direct marketing purposes, the data subject has the right to object at any time to the processing of personal data concerning them for such marketing purposes, including profiling to the extent that it is related to such direct marketing.**
4. If the data subject has objected to processing for direct marketing purposes, personal data will no longer be processed for those purposes.

## 4. Disclosure of personal data to third parties

1. Personal data may be provided to recipients such as the operator's partner companies, whereby these companies may process the personal data provided solely for the purposes set out in Article 2.
2. The controller guarantees that personal data will not be disclosed to unauthorised third parties nor used for purposes other than those specified in Article 2.

## 5. Data retention period

1. Personal data will be retained for the period necessary to fulfil the purpose of its processing, but for a maximum of **12 months** from the date of consent, unless such consent is withdrawn earlier.
2. After this period has elapsed, personal data will be securely deleted.

## 6. Rights of data subjects

The data subject has the right:

- request access to their personal data;
- to request the rectification or erasure of personal data;
- to request the restriction of the processing of personal data;
- object to the processing of personal data;
- withdraw consent to the processing of personal data at any time by writing to the email address [info@capitalmarkets.sk](mailto:info@capitalmarkets.sk) ;
- Lodge a complaint with the Office for Personal Data Protection;
- Lodge a complaint with the controller at [compliance@capitalmarkets.sk](mailto:compliance@capitalmarkets.sk) or in writing to the controller's address.

## 7. Final provisions

- By granting consent to the processing of personal data, the data subject confirms that they have been made aware of the content of these terms and conditions and that they understand their rights.

The legal basis for the processing of personal data is my explicit consent pursuant to Article 6(1)(a) of the GDPR.

### 4. Withdrawal of consent

I may withdraw my consent at any time by sending a request to the email address [info@capitalmarkets.sk](mailto:info@capitalmarkets.sk) . I may also contact the controller with this request by other means (via another official email address, in writing by post, by telephone on a recorded line, etc.).

Withdrawal of consent does not affect the lawfulness of the processing of personal data prior to its withdrawal.
